

## Regulations of promotion 'BOX Plus'

1. These regulations define the terms and conditions of the promotion under the name "BOX Plus".
2. The Promoter of the Promotion is PWM Edition (Polskie Wydawnictwo Muzyczne) with its seat: 31-111 Kraków, al. Krasińskiego 11a, entered into the register of cultural institutions kept by the Minister of Culture, National Heritage and Sport under the number RIK 92/2016, NIP 676 2502246, REGON 363717113, hereinafter referred to as PWM.
3. The promotion starts on 27/05/2021 and lasts until 25/06/2021 or while stocks last. PWM reserves the right to extend or shorten the promotion period.
4. The promotion is addressed to schools and music institutions, libraries, bookstores located in Poland and to individual customers using an online bookstore.
5. The subject of the Promotion is a package of CD, book and sheet music publications (5 versions to choose from), selected by PWM, including BOX 100 out of 100 - Musical Decades of Freedom and albums from the ANAKLISIS series, and books from the HERE OF POLISH MUSIC series DMP) and sheet music from the STRUMENTO series; offered at the price of PLN 349.00. The package price is the final price. The promotion cannot be combined with other promotional campaigns, in particular with: rebate codes, bookstore rebates, rebates for employees and authors.
6. The package content is determined by the PWM. The customer cannot choose the products that will make up the package. The content of the package may change as the stocks of individual titles run out.
7. One customer may purchase any number of promotional packages.
8. All customers can purchase via the online store at [www.pwm.com.pl](http://www.pwm.com.pl). In addition business clients can place an order by contacting the sales department via e-mail [sales@pwm.com.pl](mailto:sales@pwm.com.pl).
9. The cost of shipping the package is covered by the customer. Shipment is carried out via FedEx courier.
10. Orders can be only paid via the online payment system.
11. Institutional and business customers are not entitled to return the package purchased under the Promotion.
12. An individual customer may return the goods purchased via the online store, in accordance with the regulations of the PWM online store, available at: [https://pwm.com.pl/pl/page/regulamin\\_sklepu\\_internetowego.html](https://pwm.com.pl/pl/page/regulamin_sklepu_internetowego.html)
13. An individual customer may make a return referred to in point. 12, without giving any reason, under the following criteria:
  - a) The returned goods may not be used, copied or damaged in any way.
  - b) The customer is obliged to return the goods to the PWM bookstore at his own expense.
  - c) The customer is obliged to present the proof of purchase.
  - d) After receiving the goods by the stationary bookstore, the total cost of the order will be refunded to the Customer by bank transfer or in cash, depending on the form of payment selected when purchasing the package.
14. The promotional package may only be returned in full. The customer is not entitled to withdraw (return) only some of the products from the package purchased under the Promotion.
15. The discounted product price is only valid for bundled purchase.
16. The Organizer is not responsible for incorrect use of the Promotion.
17. Personal data of Promotion participants will be used based on applicable law, in particular Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC and the Act of 10 May 2018 on the protection of personal data.
18. Participation of the participant in the Promotion means acceptance of the Promotion rules contained in these regulations and - in the case of orders placed via the online store - acceptance of the rules of the online store, published on the PWM website.
19. Any complaints regarding the Promotion may be submitted, in particular, by e-mail to the e-mail address [handl@pwm.com.pl](mailto:handl@pwm.com.pl).
  - a) In order to speed up the consideration of the complaint, please provide a description of the reasons justifying the complaint.
  - b) Complaints will be considered within 14 from the date of their receipt by the Promoter.
  - c) The complaint procedure adopted by the Promotion organizer does not in any way violate the rights granted to the Promotion participant under generally applicable law, including the possibility of pursuing claims in court.
20. The Promotion Organizer reserves the right to change the regulations in the event of an important reason understood as:
  - a) change in the legal provisions regulating the rules and organization of the Promotion, affecting the mutual rights and obligations of the organizer and participants of the Promotion;
  - b) extending or shortening the term of the Promotion;
  - c) change in the manner of conducting the Promotion due to technical or technological reasons;

21. In the event of a change in the regulations, the Organizer will provide a uniform text of the regulations by publishing it on the PWM website. The amendment to the Regulations does not affect orders placed as part of the Promotion before the change is made.

22. All matters not covered by these Regulations shall be governed by the provisions of the website regulations available on the website: [www.pwm.com.pl](http://www.pwm.com.pl) and generally applicable provisions of law.
